

Market Announcement

In compliance with the Dubai Financial Market listing rules and the approval of the Securities and Commodities Authority, we hereby announce the delisting of Gulf General Investments Company's shares (PJSC) ISIN code (AEG000301016) from the market, effective from the end of the trading session on Friday, June 23, 2023.

The delisting is in accordance with Article 1.13 (a) (iii) of the listing rules issued by the Dubai Financial Market and related laws, which empowers the market to delist any security that has been suspended from trading for a duration of six months or more.
