Developments that occurred to the disclosure	<p>Today, we were notified officially of the verdict issued by the Court of Appeal (Dubai Criminal Court) upholding the sentence of the first degree issued to imprisonment and fines against the accused, and the court canceled the ruling to confiscate the funds deposited with banks. The legal procedures are going to be completed and requests are submitted by the company's legal agent in Dubai to the Public Prosecution to disburse the amounts seized by banks.</p> <p>Noting that parties have the right to appeal to the judgement in accordance with the provisions of the law in the UAE regarding the penalties and financial fines against the accused except for the funds seized with banks.</p>
The financial effect of the occurring developments (if any)	The financial impact will be determined later after the Public Prosecution approves the disbursement in favor of The Commercial Real Estate Company and the transfer of the amounts seized with banks after determining their value by the Public Prosecution to the account of The Commercial Real Estate Company.
