Material Information	<p>Following the Company's disclosure published on 31 July 2023, and our previous disclosures published on 11 October 2023, 22 October 2023, and 15 May 2025, regarding the decision of the General secretariat of Private Universities Council (PUC) to reduce Library & internet subscription and students activities fees for scholarship students, we would like to inform you of the following:</p> <p>Today, Wednesday, 21 January 2026, we received a decision from our institutional subsidiaries stating that they will stop taking the provisions related to these fees effective 1 January 2026, and that the existing provision balances will be used to write off the related Trade receivable balances. This is due to the fact that neither the university nor the college has received any positive response, and there are currently no indications suggesting any amendment to the decision of the General secretariat of Private Universities Council (PUC) mentioned above.</p>
