Free Float Shares:

Pursuant to the definition set forth in Article 4 of the Listing and Delisting Rules issued by the Board of Directors' Resolution No. 11 of 2014 and its amendments:

Free float shares refer to all shares available for trading, either for purchase or sale, without restrictions. The calculation is performed after excluding from the company's shares registered in the stock exchange the following:

1. Shares owned by holding sector companies in their subsidiaries listed on the stock exchange.
2. Shares owned by major shareholders, according to the following:
 - 100% of shares required to be retained according to these rules.
 - 100% of shares in cases not subject to retention under these rules. Exclusion of 97% requires that a transaction has occurred during the year preceding the calculation date.
3. Shares owned by founders during the lock-up period referred to in Article 45 of Law No. 159 of 1981, whether at incorporation or during capital increases, provided they are not included in the shares of major shareholders.
4. Treasury shares.
5. Shares pledged for Board membership, if required by the company's Articles of Association, for the duration of the membership.
6. Shares owned by shareholders obligated under agreements or contracts to retain a percentage or number of companies shares for a certain period, for the duration of such period.

Major Shareholder: A major shareholder refers to any shareholder owning 10% or more of the company's capital shares, either directly or indirectly through affiliated gr

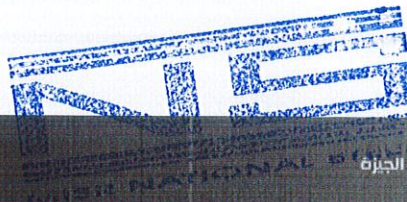
